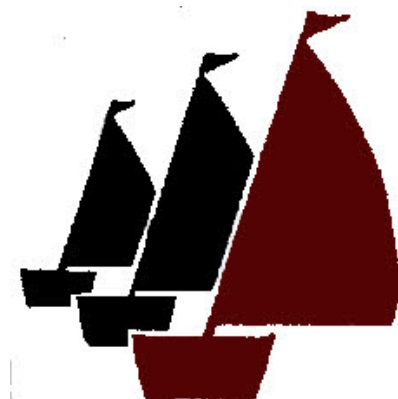

NOTES

1. Children (under the age of 18) of family memberships and Junior Members: "A parent, or a responsible adult acting "in loco parentis", must be present at all times that a junior member is present on Club premises. Any adult agreeing to act "in loco parentis" should consider how they would cope in an emergency situation. Agreeing to act on behalf of several families should be avoided." (T.S.S.C. Rule 3c)
2. The term 'in loco parentis' includes consent to medical attention and treatment being given to a child by a duly authorised medical practitioner as may be necessary on taking qualified medical advice.
3. Family members not included in Family Memberships may be introduced as guests. Members may introduce no more than two adult guests in any one day. The same person shall not be introduced as a guest on more than four occasions in any one year. Guests are not allowed to sail their own craft, only those registered with the club by a member and displaying the current boat sticker.
4. Effective personal buoyancy must be worn at all times when afloat. Wet suits, dry suits and nappy harnesses do not in themselves provide adequate personal buoyancy.
5. The buoyancy of members craft must be kept in good condition at all times.
6. Safety boats must be manned by two persons. The Helm and crew must be over 18 years of age.
7. All members aged 18 years or older are expected to carry out their rostered duties for the safety boat or race officer, or to swap with another member if they are not able to attend on the specified day.
8. Dinghies and Sailboards must display the Club sticker and have sail(s) carrying identification number(s)

EXTRACT OF RULES AND CONDITIONS FROM AGREEMENT WITH YORKSHIRE WATER

9. (8.2) To ensure that every member identifies himself/herself by showing his/her membership card of the club or other evidence of membership on request by a representative of the authority.
10. (8.4) Not to wade in the reservoir (except for launching or beaching a craft) and not to swim in the reservoir (except as necessary in case of accident).
11. (8.13) To use every endeavour not to sail within 25 yards of any person fishing
12. (8.16) Not to launch nor (except in emergency) to beach any craft outside the launching area.
